JOB SUMMARY Prepares regular and special meals for students and staff in an institutional setting; performs culinary cooking, baking and related food preparation, plans menus and utilizes leftover food; requisitions, stores and/or inventories supplies; ensures proper food sanitation and safety; cleans and sanitizes refrigerators, dishwasher, dishes, utensils, steamers, other machinery and equipment, counters and other areas used to prepare food; performs other duties as assigned.

JOB REQUIREMENTS/SKILLS Must have food service experience preparing, serving, catering food, etc., and an understanding of the principles and practices of sanitation and cleaning. Must have a current food handler's permit. This position requires moderate physical exertion such as long periods of standing, walking, recurring bending, crouching, stooping, stretching, reaching or similar activities and recurring lifting. Must be able to lift and carry up to fifty (50) pounds. Successful completion of criminal background check is required for this position.

SALARY AND BENEFITS Hourly rate \$9.60. Benefits will be limited to Social Security. This position is exempted by law from the provisions of competitive career service. The State requires employees to receive their pay through Direct Deposit or EPPICard.

ASSIGNMENT PERIOD This is a part-time position for nine (9) months (181 days) each school year. Work schedule Monday through Friday, four (4) hours per day.
