JOB SUMMARY Performs the duties of an emissary for the USDB Parent Infant Program (PIP); provides appropriate programming for blind/visually impaired students, birth to 3 years of age; prepares and writes lesson plans for each student; generates information/reports on children as appropriate; follows appropriate curriculums, as provided; provides effective home visits; advises and teaches parents in the area of vision impairment; models for parents the activities for the week; keeps appointments with families; provides and maintains equipment/materials; serves as Early Intervention (E.I.) team member; follows up on referrals; takes a collaborative role at E.I. staffings, IFSP/IEP meetings and student transitions and aids in IFSP success through appropriate assessments, including assessment of vision functioning, goal development and follow through of the IFSP; attends training sessions and workshops as assigned by program administrators; coordinates with PIP supervisor and program director; performs other duties as assigned.

QUALIFICATIONS Bachelor's degree in elementary education, early childhood, child/family studies, nursing or other related field, with a Visually Impaired endorsement (0-3) and an Early Intervention credential. Endorsement must be obtained within two years from date of hire in order to be considered for continued employment. Travel required (to home visits, meetings, workshops, etc.). Must have own transportation. Preference will be given to qualified deaf/hard-of-hearing and/or blind/visually impaired candidates. Successful completion of criminal background check is required for this position.

SALARY AND BENEFITS Salary based on Consultant Salary Schedule commensurate with education and experience. Benefits will be limited to Social Security. The State requires employees to receive their pay through Direct Deposit or EPPICard.

ASSIGNMENT PERIOD This is a part-time appointment, work schedule Monday through Friday, 10 (ten) hours per week, 42 (forty-two) weeks per year (210 contract days).
